VVBBUA fees are \$75 for the 2024 season. **New members who attend all the meetings and pass the required tests will be given a \$30 rebate at the end of the season.**

VVBBUA has Jr. High Baseball contests beginning in November 2023 and the regular High School Baseball games beginning February 2024. Therefore it is imperative that umpires interested in officiating these contests sign up early.

The 2024 membership fee covers membership, and both classroom and field instruction. Membership fee does not include uniforms nor assignor fees. Umpires are required to purchase their own officiating equipment in accordance with VVBBUA and/or CBUA uniform requirements. **VVBBUA can no longer purchase liability insurance for its members.**
